Position of the institution	<p>CCA of Stavropol region is a regional external public sector audit institution created by and accountable to the Stavropol region Duma.</p> <p>CCA of Stavropol region is a legal entity with an organizational and functional independence that can act independently within its competence.</p>
Audit remit	<p>CCA of Stavropol region has the right to carry out:</p> <ul style="list-style-type: none"> <li>- monitoring of the execution of the Stavropol region budget and the budget of the Stavropol region Territorial health insurance Fund;</li> <li>- expression of opinions on the draft laws of Stavropol region on the Stavropol region budget and the budget of the Stavropol region Territorial health insurance Fund, including the validity of indicators (parameters and characteristics) of these budgets;</li> <li>- external audit of the annual report on execution of the Stavropol region budget and the budget of the Stavropol region Territorial health insurance Fund, as well as, in cases stipulated by the Budget Code of the Russian Federation, the budgets of municipalities in Stavropol region;</li> <li>- organization and monitoring of legality, effectiveness (efficiency and economy) of use of the assets of the Stavropol region budget, the budget of the Stavropol region Territorial health insurance Fund and other</li> </ul>

	<p>sources provided by the Russian Federation legislation;</p> <ul style="list-style-type: none"> <li>- monitoring of legality of the management and disposal of property of Stavropol region, including protected results of intellectual activity and means of individualization of Stavropol region;</li> <li>- audits of the use of tax benefits, budgetary loans and other forms of support from the Stavropol region budget, monitoring of legality of public support to legal entities and individual entrepreneurs from the budget and property of Stavropol region;</li> <li>- expression of opinions on the drafts laws and other legal acts of Stavropol region (financial and economic expertise), including public programs of Stavropol region, related to the expenditures covered by the Stavropol region budget;</li> <li>- monitoring of budgetary procedures in Stavropol region, including the expression of opinions on an improvement of it and budget legislation of the Russian Federation;</li> <li>- audits of legality and efficiency of the use of interbudgetary transfers from the Stavropol region budget to the budgets of municipalities in Stavropol region and audits of the budgets of municipalities in Stavropol region according to the Budget Code of the Russian Federation;</li> <li>- information generation about the execution of the Stavropol region budget and about the budget of the Stavropol region Territorial health insurance Fund, as well as information about the results of control and expert-analytical activities, including the provision of this information to the Stavropol region Duma and to the Governor of Stavropol region;</li> <li>- participation in activities aimed at fighting corruption in Stavropol region within its competence;</li> <li>- participation as the party in a court sessions in cases stipulated by the Russian Federation legislations;</li> <li>- audits of the efficiency to determine the economy and effectiveness of the use of the assets of the Stavropol region budget and the budget of the Stavropol region Territorial health insurance Fund;</li> <li>- other powers in the sphere of external audit stipulated by the Russian Federation and Stavropol region legislations.</li> </ul>
Internal organisation	<p>Chairman of CCA of Stavropol region is its senior executive.</p> <p>Chairman, Deputy Chairman and five Auditors are elected by the Stavropol region Duma for a six-year term and are members of the Board of the Chamber.</p> <p>Other employees of the Chamber form the office of the Chamber. They assist in the implementation of the powers of CCA of Stavropol region.</p>
