Chamber of Accounts of Samara region is a legal entity with an organizational and functional independence within its competence |
| Audit remit | Chamber of Accounts of Samara region has the right to conduct: <ul style="list-style-type: none">- expression of opinions on the drafts laws and other legal acts of Samara region, including public programs of Samara region;- expression of opinions on the draft laws of Samara region on the Samara region budget and the budget of the Samara region Territorial State Non-budgetary Fund, as well as of amendments thereto;- external audit of the annual reports on execution of the Samara region budget and the budget of the Samara region Territorial State Non-budgetary Fund, as well as, in cases stipulated by the Russian Federation and Samara region legislations, the budgets of municipalities in Samara region;- expression of opinions on draft laws of Samara region on the execution of the Samara region budget and the budget of the Samara region Territorial State Non - budgetary Fund;- audits of the execution of Public programs of Samara region;- audits of use of the assets of the Samara region budget and the budget of the Samara region Territorial State Non-budgetary Fund;- audits of legality and efficiency of the management and disposal of property of Samara region; |
