Institution status	<p>The Chamber of Control and Accounts of the Leningrad region is an external state financial control body of the Leningrad region established by the Legislative Assembly of the Leningrad region and accountable to it.</p> <p>The Chamber of Control and Accounts of the Leningrad region enjoys all rights of a legal entity, as well as organizational and functional independence and carries out its activities independently.</p>
Competences of the Financial Control Authority	<p>The Chamber of Control and Accounts of the Leningrad region:</p> <ul style="list-style-type: none"> - controls the implementation of the budget of the Leningrad region and the budget of the territorial state non-budgetary fund, - carries out an expert examination of draft laws on the regional budget of the Leningrad region and the regional law on the budget of the territorial state non-budgetary fund, - conducts an external audit of the annual report of implementation of the budget of the Leningrad region and the annual report of implementation of the budget of the territorial state non-budgetary fund, - organizes and controls legality and efficiency (progress and cost effectiveness) of the use of funds of the budget of the Leningrad region, funds of the budget of the territorial state non-budgetary fund and other sources stipulated by the laws of the Russian Federation, - controls compliance with the established order of management and disposal of state-owned property in the Leningrad region (in particular, protected results of intellectual activity and means of individualization owned by the Leningrad region), - evaluates the efficiency of tax and other privileges and benefits, budgetary credits provided from the budget of the Leningrad region, as well as the legality of providing state guarantees and warranties or other enforcement of obligations for transactions concluded by legal entities and individual entrepreneurs with the involvement of funds of the budget of the Leningrad region and state-owned property in the Leningrad region, - carries out an expert financial and economical examination of draft regional laws of the Leningrad region and regulatory acts issued by public authorities of the Leningrad region with regard to expenditure obligations of the Leningrad region as well as state programs of the Leningrad region, - analyses the budget process in the Leningrad region and prepares proposals aimed at its improvement, - controls legality and efficiency (progress and cost effectiveness) of the use of inter-budget transfers from the budget of the Leningrad region to budgets of municipal divisions within the territory of the Leningrad region,

	<p>as well as checks budgets of municipal divisions in cases prescribed by the Budget Code of the Russian Federation,</p> <ul style="list-style-type: none"> - prepares information on the implementation of the budget of the Leningrad region, the budget of the territorial state non-budgetary fund, results of the relevant control, examination and analytical activities and submits such information to the Legislative Assembly of the Leningrad region and the Governor of the Leningrad region, - exercises other powers in the field of external state financial control established by federal laws and regional laws of the Leningrad region.
Internal structure	<p>The Chamber of Control and Accounts of the Leningrad region is headed by a president.</p> <p>A president, a vice-president and four auditors hold public positions in the Leningrad region are appointed by the Legislative Assembly of the Leningrad region for five years and comprise the Board of the Chamber of Control and Accounts of the Leningrad region.</p> <p>Other employees of the Chamber of Control and Accounts of the Leningrad region include inspectors and other regular employees of the Chamber of Control and Accounts, comprise the office of the Chamber of Control and Accounts and ensure exercising of powers by members of the Chamber of Control and Accounts of the Leningrad region and the Board.</p>
