Service outsourcing

- Often management buy outs
- Ex public servants
- Big companies now involved
- Mixed success
- Good track record
 - Finance services
 - Building and maintenance services
- Poor track record
 - IT
 - General management



Private Finance Initiative

Definition

" A contract which involved the provision of services and significant investment in assets/infrastructure. The contract will be long term, typically 25 years and will be for a fixed fee, indexed annually. Service risk is transferred to the private sector"

- Hospitals
- Prisons

Poor track record

- IT and communications
- Transport
- Central Government

The deal

- €2.0 billion
- 30 years
- 300,000 tonnes of waste per year
- Investment in:
 - Incineration
 - Recycling services
 - Public access waste facilities
 - Landfill



The audit challenge

- Understanding the sector
- Political dimension
- Complex financial modelling
- Accounting issues
- Affordability



Understanding the sector

- Complex engineering costs and risk
- Understanding the technology

Political dimension

- Impact of public opposition, costs etc
- Ensuring political support, largest ever contract



Complex financial modelling

- 50 pages of spreadsheets
- Small error = huge change in cost
- Were assumptions on volumes reasonable?

Accounting issues

- Is the asset base (€200m) off balance sheet
- How can you model risk?

Affordability

Will this break the Council?



The audit story

- Involved for 6 years
- Contract in operation
- Continuing issues re:
 - Assets
 - Performance monitoring
 - Risk transfer
 - Affordability
 - Contract termination



Auditing - conclusions

- Get involved early, too late = low impact
- Understand the sector = ability to impact decisions
- Understand the procurement process
- Focus on key issues
- Understand the audit client's expertise
- Engage with the procurement team
- Keep under surveillance in contract period
- Justify your fees!!
